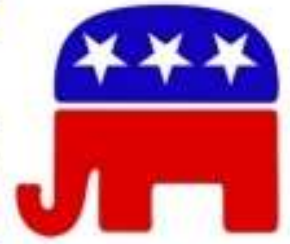

March 15th is the deadline for you to have given me any corrections or updates to your Directory contact information. Call me, text me, or e-mail me with any corrections or updates ASAP.

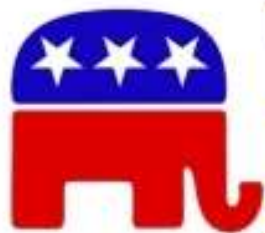

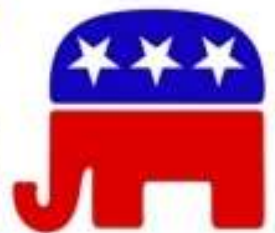

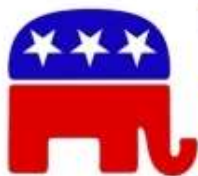
