




Mary Jenks and Lynn Pablovich offered clever questions and was enjoyed by all.



In a grand "welcome back" fashion Ann Gibbs was our big winner.




Sharon Bostwick is chairing a new committee to keep us informed about our St Tammany Parish School Board. She needs helpers. **Please see the next page for more about this committee.**


I started distributing the 2021 Directory at the April meeting and I will continue doing so at each meeting. If you are not attending meetings, let me know and you can pick it up from me.

'ROAD TO MAJORITY' ... Let's Stay In Our Lane!


