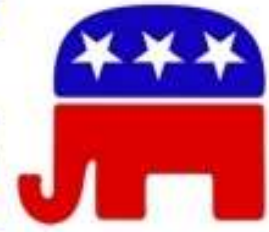

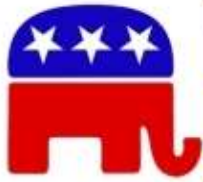

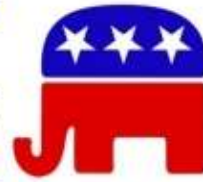

Ray Garofalo – Rep. District 103 and candidate for Senate District 1

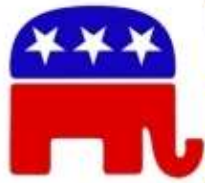

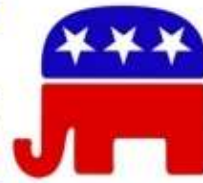

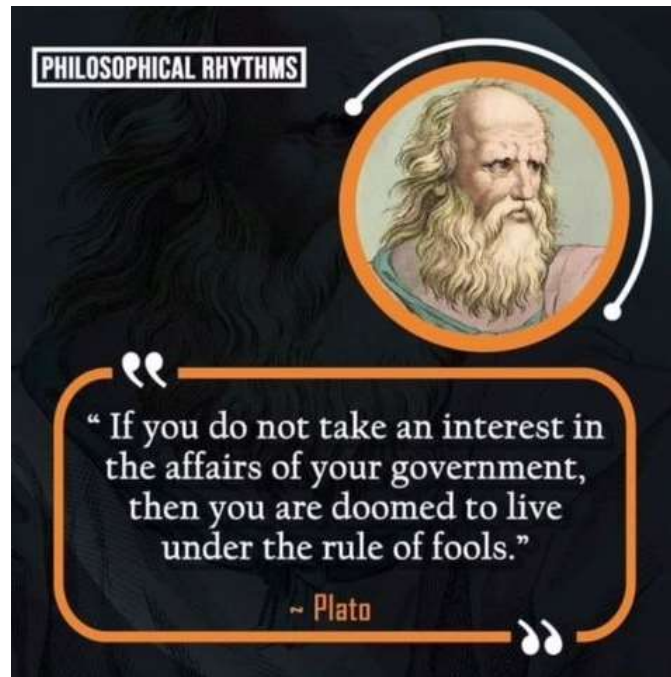
