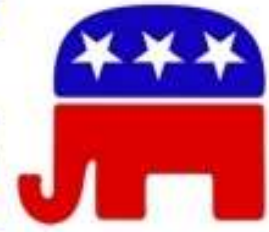

You can also pay your 2024 membership dues of \$45 as Active Member or \$15 as Associate Member at the Social.

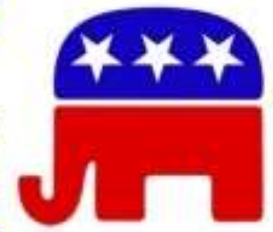


This Christmas, while families are enjoying the new year, MRW will be looking forward to a special "New Year," as 2024 is our 40th anniversary.

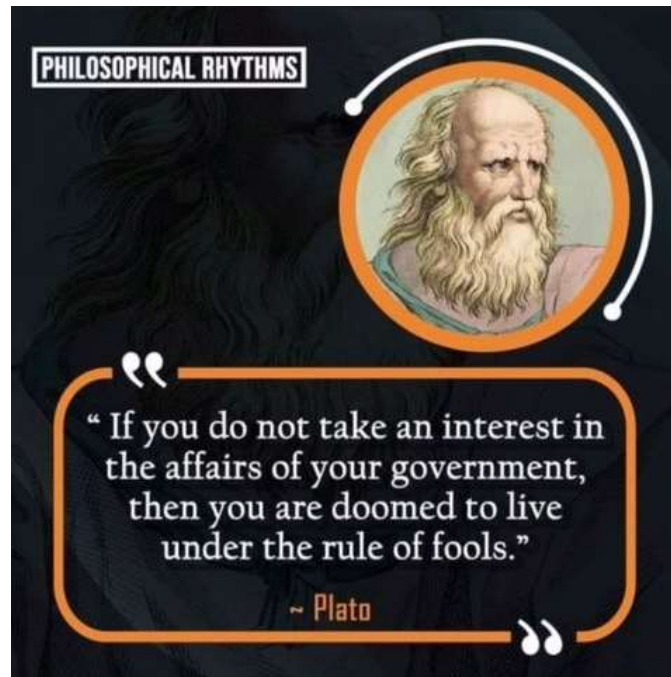


